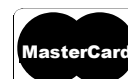
**Primary Subscription Rates:** \$195.00 *Annually (24 issues)*  
\$99.00 *Semi-Annual (12 issues, 6 months)*  
\$16.00 *Monthly (2 issues)*

**Secondary Subscription Rates:** \$24.00 *Annually (24 issues)*  
(See qualifying information below) \$15.00 *Semi-Annual (12 issues, 6 months)*  
\$3.00 *Monthly (2 issues)*  
*by automatic credit card payment plan*

**Associate Subscription Rate:** \$145.00 *Annually (24 issues)*  
(See qualifying information below)

**Full-time Law Student Rates:** \$97.50 *Annually (24 issues)*  
\$75.00 *School term (18 issues, 9 months)*

All subscriptions are billed in advance. Monthly plans available by credit card only. We accept these credit cards for all subscriptions, monthly plans and other subscription services.



### Qualifying information for Secondary and Associate accounts

- Secondary accounts must be associated with a primary full priced account of \$195 yearly, \$99 semi-annually or \$16 monthly for automatic credit card payment plans.
- Secondary accounts must share the same mailing address and expiration date as the primary account. While the same mailing address is required, the firm may use whatever means it desires to distribute secondary subscriptions within its own firm including its own satellite offices. Maine Lawyers Review will be happy to pro-rate add on secondary accounts to meet the expiration date requirement.
- Same firm subscriptions mailed to a different address or with a different expiration date do not qualify as a secondary account but as an associate account of \$145 per year. Secondary subscriptions may not be attached to associate accounts.
- Secondary accounts meeting the above criteria are available to the following entities: Law firms, private and public companies, non-profit organizations and government entities at the agency or departmental level.

### Automatic credit card plan
